

# COUNTY OF ATHABASCA NO. 12

## BY-LAW 6 – 2004

---

**A By-Law of the County of Athabasca No. 12, in the Province of Alberta, to authorize the rate of taxation for all purposes for the year 2004.**

**WHEREAS,**

the probable expenditure of the County of Athabasca No. 12 for the calendar year 2004 for all purposes totals \$25,089,956 as shown by the estimates approved by Council at its May 11, 2004 County Council Meeting; and

**WHEREAS,**

the probable revenue from all sources, other than taxation is estimated at \$16,406,942.00 as shown by the said estimates, thus leaving a balance of \$8,683,014.00 to be raised by taxation; and

**WHEREAS,**

the assessed value of all lands and improvements in the County of Athabasca No.12 as shown on the assessment roll is estimated at:
